- The processing time for the Master's thesis is **6 months**. The Examination Office will inform the student of the exact date for the latest possible deadline for the submission of the Master's thesis by e-mail.
- The topic can be proposed by any authorized person (usually professors or private lecturers). The proposal of the topic is linked to the obligation to supervise the Master's thesis. The topic, task and scope of the Master's thesis must be limited in such a way that the deadline for completion can be met. The topic of the thesis can be returned once within the first four weeks and is then deemed not to have been issued.
- The Master's thesis is evaluated by two authorized examiners (usually professors or private lecturers), one of whom must be a member of the Institute of Biology at Freie Universität Berlin.
- The Master's thesis may also be completed externally, i.e. at an institution outside the Institute of Biology at FU Berlin, with the approval of the Examination Board. The necessary **application form for external conduction** can be submitted to the Examination Office in advance or must be submitted together with this registration form at the latest.
- Accompanying the Master's thesis, a **20-minute presentation** of the concept and results of the thesis with a scientific discussion is mandatory. This presentation is **not** included in the overall grade for the Master's thesis.
